The Chairmen welcomed all Hon'ble Members in this special meeting of Academic Council and asked the Member-Secretary to explain the necessity of calling this special meeting. In turn, the Member-Secretary explained that in view of the decision taken by the Academic Council vide Item N0. 10. of its Meeting held on 26. August, 2015 regarding granting of special chance of examination for passing out students with low CGPA, this special meeting of the Academic Council has been convened. Thereafter, with permission of the chair, he invited Hon'ble Members to deliberate upon the issue and take necessary decision. The Academic Council discussed the issue in detail and decided as under:

The Council, after a great discussion, concluded that a special chance be given to all the students with CGPA less than 3.0 and passing out students more than 5(five) re-appears with CGPA less than 3.0 be given two special chances. Also, it was decided that the second special chance to the re appear students will be given before DEC-2015. The detail of such students is below:


Any other Item with the permission of Chair.

The following items were taken up for consideration and decision of the Academic Council with the permssion of Chair under this Item:

Item No. 1 Introduction of choice based credit system from session 2016-17.

The Dean Academic Affairs informed that UGC. has directed all universities to Introduce Choice Based Credit System (CBCS) in UG and PG Programs. HP-PERC has also recommended for moving towards CBCS as early as possible. He also informed that the present system is lacking:-

- Inter-disciplinary mobility
- Choices for the students
- Latest knowledge in the curriculum
- Quizzes
- Field work
- Community involvement
 - •He further informed that that in the CBCS System the curriculum will be inter disciplinary enabling integration of concepts, theories and techniques of other disciplines to solve problems facing by the community. Further in CBCS system:-
- Candidate can learn at its own pace.
- Can choose from wide range of courses
- Will help entrepreneurship
- It will Enhance employability and vocational training





The Academic Council, after a good deal of discussion, decided to adopt the CBCS from the session 2016-17 subject to formal approval of HP Govt. / HP-PERC for which a Committee to be constituted by the Dean Academic Affairs with the approval of Hon'ble Vice- Chancellor shall finalize the ways and means for implementing the scheme.

Item No.2 To introduce General Fitness Course in professional programs.

The Dean Academic Affairs explained the importance and necessity of General Fitness Course in Professional Programs and requested the Academic Council to consider the proposal for the introduction of General Fitness Course in Professional Programs in the University. The Council, after deliberation on the issue, approved the proposal for introduction of General Fitness Course in the University for which a Committee to be constituted by the Dean Academic Affairs with the approval of Hon'ble Vice-Chancellor shall complete necessary codal formalities.

The Hon'ble Chairmen also suggested that the Certified Foreign Language Course should also be implemented which will be useful to all those passing out students who are willing to go abroad for their further Studies/Jobs. The Faculty members can also join this course. The Academic Council appreciated the idea of Hon'ble Chairman and unanimously approved the said proposal. The Committee to be constituted for finalizing the formalities for introduction of General Fitness Course in professional program shall also prepare and finalize a complete proposal in this regard.

Item No.3 To approve the decision taken by Examination Cell for reported UFM Cases during summer session.

The examination cell reported the UMC Cases made during the summer examination held in July, 2015 before the UFM Committee. The Committee comprising Er. Randeep Singh Convener & Ms. Esha Bansal Member decided as under:-
